



**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE FEDERATED STATES OF MICRONESIA  
AND  
THE REPUBLIC OF SEYCHELLES**

The Government of the Federated States of Micronesia and the Government of the Republic of Seychelles;

Desirous of promoting mutual understanding, and strengthening the friendship and cooperation between the two countries in the political, economic, cultural and other fields;

Based on the principles and objectives of the Charter of the United Nations, International Law and Treaties, in particular with regard to the promotion of international peace and security, equality among States, national sovereignty, independence, territorial integrity and non-interference in the internal affairs of other States;

Have decided to establish diplomatic relations, at the level of Ambassadors, including consular relations, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, and to base their consular relations on the Vienna Convention on Consular Relations, done on April 24, 1963, with effect from the date of signing of this Joint Communiqué.

In witness whereof, the undersigned, being duly authorized thereto by their respective Governments, have signed this Joint Communiqué.
